



Judging Criteria

The Bracco Italiano Society Judging List – A1 Breed and Non breed specialist

Judges who have been approved by the Kennel Club to award challenge certificates for the breed, have completed their first appointment and have the support of the society.

The Bracco Italiano Society Judging List – A2 Breed and non breed specialist

Judges who fulfil the requirements of the A3 criteria, have been assessed in accordance with the Kennel Club requirements, approved by the Kennel Club for inclusion on the list and have the support of the society. The A2 list also includes those judges accepted via the grandfather route.

The Bracco Italiano Society Judging List – A3 Breed specialist

Judges who are supported by the society as being suitable to award challenge certificates in the breed, but not yet approved by the Kennel Club for inclusion on the A2 list.

Requirements

- A minimum of 7 years judging experience in the breed and to have the support of The Bracco Italiano Society **(KC Policy)**
- To have judged the breed at 3 open or championship shows without CCs with an adequate geographical spread.
- To have judged a minimum of 40 dogs. **(KC 2022 Tier 2)**
- To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on KC Regulations and Judging Procedure. **(KC Policy 1.7.2001)**
- To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement **(KC Policy 1.7.2001)**
- To have attended a Points of the Dog Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment. **(K C Policy 1.7.2005)**
- To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club code of best practice and passed an examination and/or assessment where applicable. **(K C Policy 1.7.2001)**
- To have bred and/or owned a minimum of 3 dogs when they obtained their first entry in the Kennel Club Stud Book. (Save in exceptional circumstances)
- To have stewarded at 12 shows. **(KC Policy)**
- To attend a KC Field Trial (Open Stake) or an Open Gundog Working Test for HPR breeds. **(KC Policy)**

The Bracco Italiano Society Judging List – A3 Non breed specialist

Judges who are supported by the society as being suitable to award challenge certificates in the breed, but not yet approved by the Kennel Club for inclusion on the A2 list.

Requirements

- A minimum of 5 years judging experience in the breed and to have the support of The Bracco Italiano Society **(KC Policy)**
- To have judged the breed at 6 open or championship shows without CCs with an adequate geographical spread.
- To have judged a minimum of 40 dogs. **(KC 2022 Tier 2)**
- To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on KC Regulations and Judging Procedure. **(KC Policy 1.7.2001)**
- To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement **(KC Policy 1.7.2001)**
- To have attended a Points of the Dog Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment. **(K C Policy 1.7.2005)**
- To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club code of best practice and passed an examination and/or assessment where applicable. **(K C Policy 1.7.2001)**
- To have bred and/or owned a minimum of 3 dogs when they obtained their first entry in the Kennel Club Stud Book. (Save in exceptional circumstances)
- To have stewarded at 12 shows. **(KC Policy)**
- To attend a KC Field Trial (Open Stake) or an Open Gundog Working Test for HPR breeds. **(KC Policy)**

The Bracco Italiano Society Judging List – B Breed specialist

Judges whom the society would support to judge the breed at championship shows without CCs or at open shows.

Requirements

- A minimum of 5 years judging experience in the breed and to have the support of The Bracco Italiano Society
- To have judged a minimum of 20 dogs.
- To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on KC Regulations and Judging Procedure.
- To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement
- To have attended a Points of the Dog Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment.
- To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club code of best practice.

The Bracco Italiano Society Judging List – B Non breed specialist

Judges whom the society would support to judge the breed at championship shows without CCs or at open shows.

Requirements

- To have judged a minimum of 20 dogs.
- To have attended a seminar given by a Kennel Club Accredited Trainer and passed the relevant examination on KC Regulations and Judging Procedure.
- To have attended a seminar given by a Kennel Club Accredited Trainer on Conformation and Movement
- To have attended a Points of the Dog Assessment conducted by a Kennel Club Accredited Trainer and passed the assessment.
- To have attended at least one breed specific seminar run in accordance with the relevant Kennel Club code of best practice.

The Bracco Italiano Society Judging List – C Breed specialist

Aspiring judges who do not meet any of the other judging list requirements, have owned the breed for at least two years and have the support of the society to judge at open shows.

The Bracco Italiano Society Judging List – C Non breed specialist

Aspiring judges who do not meet any of the other judging list requirements, have demonstrated an interest in the breed and have the support of the society to judge at open shows.
